But sometimes we do need information to provide services that you request, and this privacy statement explains data collection and use in those situations. ## Collection of your Personal Information

We will ask you when we need information that personally identifies you (personal information) or allows us to contact you. Generally, this information is requested when you are requesting information using our enquiry form, subscribing to e-mail newsletters or signing up for an event or training. Personal information collected by [www.corporateprotectivewear.co.uk](http://www.corporateprotectivewear.co.uk) & associated web sites often is limited to basic contact information relevant to a particular service, but may include other information when needed to provide a service you requested.

This information may include: your IP address, browser type, operating system, domain name, access times and referring Web site addresses. This site visitation data is identified only by a unique ID number, and it is never linked with personal information.

## Use of your Personal Information

We use your personal information for the following purposes:

To ensure our site is relevant to your needs.

To deliver services, such as newsletters, events, training or software, that you request or purchase.

To help us create and publish content most relevant to you.

To alert you to product upgrades, special offers, updated information and other new services from Corporate & Protective Wear, if you so request.

To allow you access to limited-entry areas of our site as appropriate.

We occasionally hire other companies to provide limited services on our behalf, including packaging, mailing and delivering purchases, sending postal mail and processing event registration. We will only provide those companies the information they need to deliver the service, and they are prohibited from using that information for any other purpose.

Corporate & Protective Wear may disclose your personal information if required to do so by law or in the good-faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Corporate & Protective Wear or the site; (b) protect and defend the rights or property of Corporate & Protective Wear and its family of Web sites, or (c) act in urgent circumstances to protect the personal safety of Corporate & Protective Wear employees, users of Corporate & Protective Wear products or services, or members of the public.
